Source: PROFILE.

LOCATION ELIGIBILITY

- HIGH: Address looks like a PO box, mailbox, or virtual-office setup. The address contains wording commonly associated with mailbox or virtual-office risk patterns. Recommendation: Review whether the location is publicly eligible and gather strong location proof before moving the case forward. Evidence needed: utility_bill, lease_agreement, storefront_exterior_photo, signage_photo. Confidence: HIGH. Source: PROFILE.

BUSINESS IDENTITY

- HIGH: Business name may be keyword-stuffed. Contains marketing-style language that looks promotional rather than factual. Recommendation: Use the factual business name customers know in the real world and capture before-and-after proof of the cleanup. Evidence needed: client_written_explanation, profile_screenshot, business_registration. Confidence: HIGH. Source: PROFILE.
- MEDIUM: Profile name differs from the provided business identity. The profile name does not exactly match the provided business or legal name, which should be checked before a case moves forward. Recommendation: Document which name is correct and align the profile, website, and identity documents around that final choice. Evidence needed: business_registration, client_written_explanation, profile_screenshot. Confidence: HIGH. Source: PROFILE.

OWNERSHIP VERIFICATION

- HIGH: Profile is unverified. An unverified profile makes it harder to prove control and stability while the case is active. Recommendation: Prepare identity and location evidence before making more sensitive profile changes. Evidence needed: profile_screenshot, business_registration, utility_bill. Confidence: HIGH. Source: PROFILE.

CONTACT CONSISTENCY

- HIGH: Profile phone is missing. A missing phone number weakens contact consistency and makes the case harder to support with public evidence. Recommendation: Add the correct business phone number and capture supporting evidence that the number belongs to the business. Evidence needed: website_contact_page_screenshot, phone_bill, profile_screenshot. Confidence: HIGH. Source: PROFILE.
- HIGH: Profile website is missing. A missing website leaves the profile without one of the easiest public identity checks. Recommendation: Add the correct website and collect website contact-page screenshots for the case file. Evidence needed: website_contact_page_screenshot, profile_screenshot. Confidence: HIGH. Source: PROFILE.

CATEGORIES

- **MEDIUM:** Primary category is missing. The profile does not currently show a primary category, which removes a basic relevance signal. Recommendation: Select one primary category that accurately describes the main business activity and document why it fits. Evidence needed: client_written_explanation, profile_screenshot. Confidence: HIGH. Source: PROFILE.

RECENT CHANGES

- **MEDIUM:** Recent sensitive profile changes were detected. One or more sensitive fields changed recently, so the case should keep a clear internal timeline. Recommendation: Record what changed, why it changed, and what supporting evidence confirms the current values. Evidence needed: client_written_explanation, profile_screenshot. Confidence: HIGH.
